His novels and short-stories are full of attraction, moral lessons and refreshing doldrums for readers along with researcher to analyze his work (Bassett, 2020; Kearin, 2020; Otomo, 2020). "The Beach at Falesá" along with "The Ebb Tide" is best novels of the Robert Louis Stevenson as well as full of food for book lovers (Hoffenberg, 2016; Mellifont, 2017). The first novel is comprised of 70 pages while the other one is consist of 131 pages (Joll, 2016; Alexander, 2017; Manfredi, 2018). Both novels are the clear depiction for expertise of the writer for explaining the most awful situations of the

present world in a beautiful way (Milne, 2016; Rita, 2017; McAuley, 2019). The author's way of talk and to explain his work is different from many other authors that are well known as travel writers (Stott, 2004; Larsen, 2015).

Robert Louis Stevenson was suffering from the fatal disease of lung hemorrhage and according to the recommendations of the doctor he had travelled towards the islands bestowed with affectionate ambiance (Scott, 2007; Levin, 2008; Pham-Thanh, 2011; Cunningham, 2016). However, his visit to the islands gave him new wave of spirit and courage and consequently, instead of dying within the wait of death due to poor heath, he started using his energy to write down the marvelous stories and novels including "The Ebb Tide" and "The Beach at Falesá" (Orr, 1999; Treagus, 2014; Burrow, 2016).

In the chronicle of "The Beach at Falesá" the narrator characterize the foreigner trader named as "Wiltshire" as the leading role of the story along with the native broker named as "Case" (Robinson, 2019; Osment, 2019). Wiltshire was a man of principles as well as above suspicion character; however, the native trader considers him the foolish one and try to taboo him by arranging an monstrous caricature type marriage ceremony between Wiltshire and Uma (Alliata, 2006; Wall and Sarah, 2017). Later on, when the Wiltshire realized the actual scene that had happened to him, Case instead of becoming ashamed try to show arrogance as well as threaten him that he will completely destroy him if he tried to go against him (Dryden, 2011; Treagus, 2014). Uma was considered as the bad woman and thus, by making her excuse the whole island brings to a standstill for making business dealings with the Wiltshire (Stevenson, 2005; Macleod and David, 2014). Here, the story depicts the horrible face and temptation of human beings for each other (Jackson, 2000; Harris, 2003; Ferrini, 2012). The awful fact about human beings is that they never become satisfy with whatever they have rather try to destroy the other one and feels leisure in this dreadful act (Nakai, 2000; Jolly, 2004; Olesha, 2019).

Similarly, in the other story "The Ebb Tide", author also enlightens the devastating phenomenon of the society that can be explained well by using the theory of "Cannibalism" (Kindler, 2005; Jolly, 2006). However, all three redundant persons decide to steal the ship and make their life happiest. Thus, this is another story that is clearly supporting the theory of cannibalism in which the three persons are trying their best to cheat the others and commit the unacceptable misdemeanors (Davidson, 2004; Di Frances, 2012; Alexander, 2017).

Later on, when the Wiltshire try to inquire about all this happening Case threat him that he will kill him if he tried to stand in front of him and the Wiltshire becomes silent over all this unbearable behavior and strengthen him with courage and patience.

Mellifont (2017) is of the view that love is the most important attribute of every society to as well as the basic parameter of success of every man. In his article the author explains the example of love between Uma and Wiltshire. He says that although many devil natured persons tried to separate them by deteriorating their social as well as personal life. Case, the villain of the story pressurizes the whole community to discontinue their dealings with Wiltshire and consequently, tried to destroy the family of him. However, unconditional love of Wiltshire for Uma did not let them stop their journey of life. Contrary to this, bad company and evil spirit people destroy not only to them rather the company and friends of them that they have. Similar phenomenon was observed in the story "The Ebb Tide", three losers of life became friends. Once they were assigned to bring one ship to the destined position but they made a plan to steal the material and brought the ship to the fake destination and found nothing. These sentences explicate the innocence of "Wiltshire", moreover, it is also clear that he is simple, pure and kindhearted person. Not even a bandit! and to be starving here with worse than banditti—with this trivial hell-hound!" His rage against his comrade rose and flooded him, and he shook a trembling fist at the sleeper". The above explained text citation enlightens the application of Cannibalism on the story of "The Ebb Tide". It explains that first three friends that were helpless from life and used to find failure everywhere and then, suddenly find an opportunity to change their life.
